

# CHALLENGER STANDARD NOTICE OF RACE, PART 1 (2021)

The Organising Authority is the Club named in Notice of Race Part 2 - the Specific Venue details for the relevant regatta date - which will be published in Challenger News or online before the event

## 1. RULES

- 1.1. All regattas will be governed by the rules as defined in The Racing Rules of Sailing, the Challenger Class Design rules, the Challenger Standard Sailing Instructions and any Local Sailing Instructions published by each Specific Venue
- 1.2. The Class Design rules and Challenger Standard Sailing Instructions are available on application to the Class Chairman or from the Class website [www.challenger-sailing.org.uk](http://www.challenger-sailing.org.uk). Standard and Local Sailing Instructions will also be available and on display at registration for each regatta.

## 2. ELIGIBILITY & ENTRY

- 2.1. Regattas are open to all marks of Challenger but the maximum sail area shall be limited to 7.9 square metres (equivalent to the Una-rig sail). i.e. Mk3 boats shall furl jibs
- 2.2. For 10 or more competitors, the final Event Session may be split into A and B Fleets, based on series results. Medal Race Supplementary Sailing Instructions will be used to decide Gold and Silver prizes. The **Bronze Fleet** will compete as part of the B Fleet and will be awarded separate prizes but are eligible to win B Fleet prizes also
- 2.3. **All participating helms shall be members of the Challenger Class Association.** Competitors may choose to enter one of the categories below but, alternatively, may be seeded by Series Results if Medal Races are used as in 2.2 above.

**Standard-** All Competitors, able-bodied or with disabilities, who are capable of sailing solo for the whole of an event. If 2.2 is not applied, Standard Fleet competitors may be divided into:

- **Gold:** Experienced racers either able-bodied or with disabilities. Silver fleet sailors with 3 or more previous Silver wins
- **Silver:** Less experienced racers or disabilities that significantly limit boat handling and performance

**Syndicate-** For sailors **with a disability** who:

- Share the boat during a regatta. Each individual must sign the entry form and compete in at least one race but not in more than 50% of the programmed races.
- The cumulative score for the boat will determine the series score of the Syndicate and all members will share the prize. Unless Medal Races are used, they will sail in the Silver Fleet

**Bronze Fleet-** for sailors **with a disability** who:

- All carry a *mandatory* buddy on board whilst racing. This Fleet is limited to sailors who are; very inexperienced or have never raced before, visually impaired, unable to operate all controls without help due to mobility or strength issues. sailors with learning difficulties.

- 2.4. Eligible boats may enter by completing the Challenger Standard Regatta Entry form and sending it, **at least two weeks in advance**, to the organiser's address shown in Notice of Race Part 2. Postal or equivalent email entries *will be acceptable*.

- 2.5. If organisers do not receive an advance entry form, to help with Event Planning there may be a late entry supplement of up to £5.00 payable at registration

**3. PRIZES** Details of prizes (usually consisting of trophies etc.) are shown in Notice of Race Part 2 for each venue, published in Challenger News or shown on Social Media

**4. FEES** Entry fees should be paid to the organisers **at registration on arrival at the venue**

**5.SCHEDULE AND OTHER VENUE-SPECIFIC DETAILS** The schedule of races and list of prizes will be published either in Challenger News, on Social media or by email before each event. Other details will be shown in the Challenger Standard Sailing Instructions or their supplements.

## 6. PENALTIES

As an **alternative to protests**, an Exoneration Penalty (and an Advisory Hearing or RYA Arbitration) of the RYA Rules Disputes procedure will be available. Details to be posted on Regatta Notice Board

## 7. SAILING INSTRUCTIONS

The Challenger Standard Sailing Instructions will be used. They are available to download from the website [www.challenger-sailing.org.uk](http://www.challenger-sailing.org.uk) or on demand from the Class Chairman and will be displayed on the Event Notice Board at each regatta

## 8. VISUAL IMAGES CONSENT

By signing the entry form, Competitors grant the Organising Authority or their agents, without payment, the right in perpetuity to make, use and show or publish any motion pictures, still pictures and live or recorded coverage in any media of, or relating to, the Regatta, unless they advise the organizers otherwise in writing prior to the Regatta.

## 9. DATA PROTECTION

The personal information you provide to the organising authority will be used to facilitate your participation in the event. If you have agreed to be bound by the Racing Rules of Sailing and the other rules that govern the event (the rules), the legal basis for processing that personal information is contract. If you are not bound by the rules, the legal basis for processing that personal information is legitimate interest. Your personal information will be stored and used in accordance with the organising authority's privacy policy. When required by the rules, personal information may be shared with the RYA and/or World Sailing. The results of the event and the outcome of any hearing or appeal may be published.

## 10. RISK STATEMENT

Rule 3 of the Racing rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone".

Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

- (a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
- (b) They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;
- (c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- (d) Their boat is in good order, equipped to sail in the event and they are fit to participate, including survival in the water, taking into account any disability they might have;
- (e) The fact that Race Officials may conduct inspections of a boat does not reduce the responsibilities of each competitor set out in this Notice of Race
- (f) The provision of a Race Management Team, Patrol Boats or other officials and volunteers by the Event Organizers does not relieve them of their own responsibilities;
- (g) The provision of Patrol Boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances;
- (h) It is their responsibility to familiarise themselves with any risks; specific to their disability if any, at a particular venue or event or drawn to their attention in any rules or information produced for the venue or event **and to attend any safety briefing held for the event;**
- (i) Their boat is adequately insured, with cover of at least £3,000,000 against third party claims.

## Standard Course Layout -Trapezoid (Identified as COURSE 1)

Distances are examples to achieve an approximate lap time of 10-15 minutes

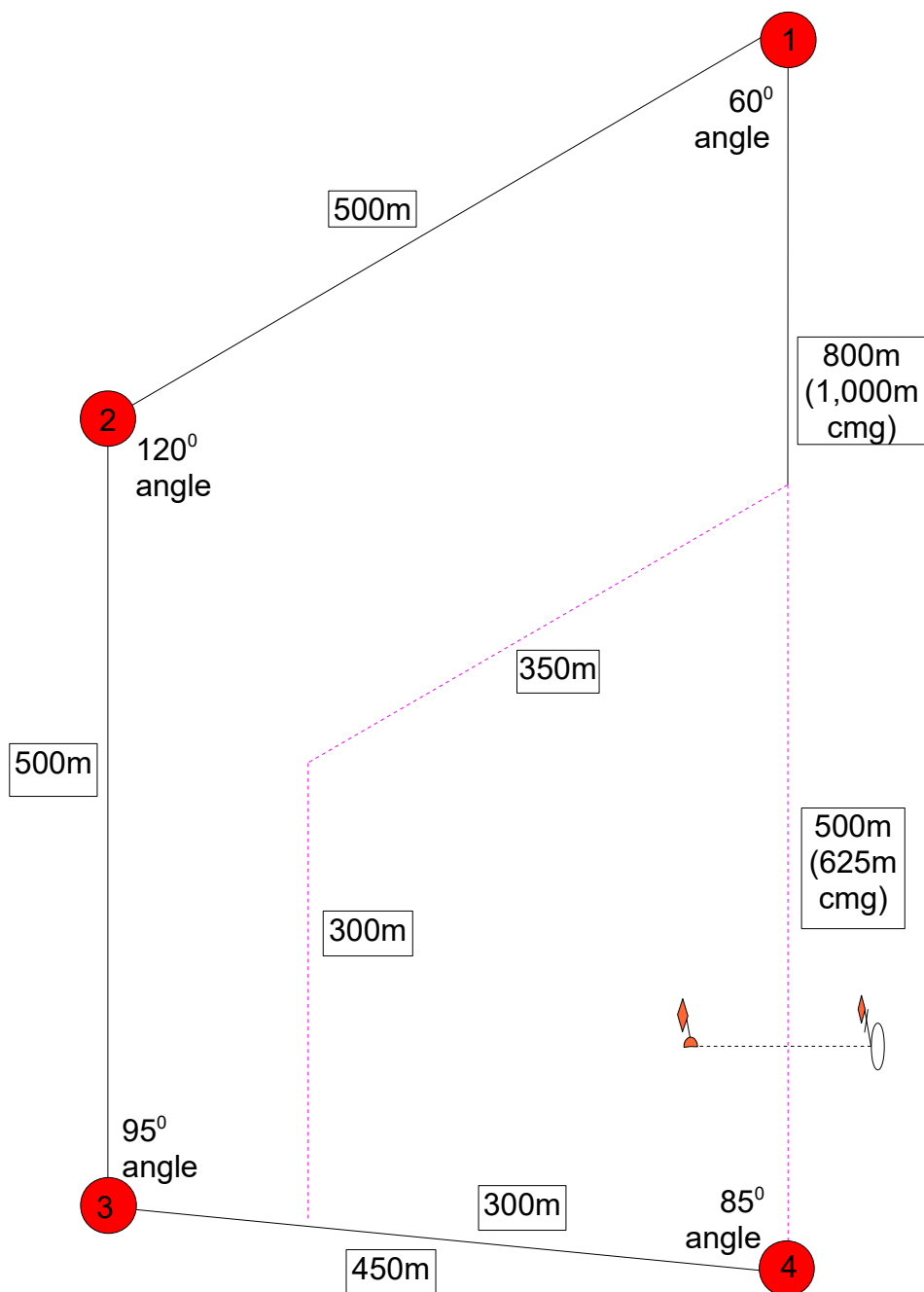
**Black lines = Moderate to Fresh Winds**

**Magenta lines = Light Winds (0-5 knots)**

“CMG” (Course Made Good) shows total distance sailed when beating

Red marks should be left to PORT. The Start / Finish line is also an Upwind Gate

Start Sequence (Rule 26) = 5 min. 4 min. 1 min. GO



**Standard Course layout-Triangle (Identified as COURSE 2)**

**Distances are examples to achieve an approximate lap time of 10-15 minutes**

**Black lines = Light Winds (3-6 knots) or more**

**Magenta lines = Very Light Winds (0-3 knots)**

**“CMG” (Course Made Good) shows total distance sailed when beating**

**Red marks should be left to PORT. The Start / Finish line is also an Upwind Gate**

**Start Sequence (Rule 26) = 5 min. 4 min. 1 min. GO**
